Myer Supply Chain - Advertised Label Requirements

Requirement for Advertised Line Label on Cartons / Hangwear / Bulky Items

In order to improve the Myer Supply Chain delivery process we require an Advertised Line label to be included in the labelling of Merchandise. This label is in addition to the Advertised Date detailed on the SSCC label and helps identify that the merchandise is urgent floor stock. The advertised stock can then be prioritised as urgent stock when received at the back of stores and is then quickly displayed on the shop fixtures.

If the Order has been flagged with an Advertised Date, this date is sent through on the Purchase Order and will print on the SSCC label. Any carton or hangwear bag delivered either to the Distribution Centres or Direct to Store, which is advertised must have the Fluoro Yellow Advertised Line Label.







The Advertised Line Label dimensions are 100mm x 50mm, colour must be Fluoro Yellow The Advertised Line Label must be clearly separate from the SSCC (No Overlap)

Myer Supply Chain - Stocktake Sale Label Requirements


Requirement for Stocktake Sale Label on Cartons / Hangwear / Bulky Items

In order to improve the Myer Supply Chain delivery process for STOCKTAKE SALE Orders we now require that a STOCKTAKE SALE label is included in the labelling of Merchandise. This label helps identify that the merchandise is urgent floor stock for the STOCKTAKE SALE. The stock can then be prioritised as urgent stock when received at the back of stores and is then quickly displayed on the shop fixtures. Due to the overlap between Stocktake Sale and other Myer advertised events, we have created a separate label identifier for Stocktake Sale.



The STOCKTAKE SALE Label dimensions are 100mm x 50mm, colour must be RED The STOCKTAKE SALE Label must be clearly separate from the SSCC (No Overlap)
